Your Information. Your Rights. Our Responsibilities.

This notice describes how your health information may be used and disclosed and how you can get access to this information.

Please review it carefully.

Your Rights

When it comes to your health information, you have certain rights.

This section explains your rights and some of our responsibilities to help you.

Get a copy of your health and claims records	 You can ask to see or get a copy of your health and claims records and other health information we have about you. Ask us how to do this.
	 We will provide a copy or a summary of your health and claims records, usually within 30 days of your request. We may charge a reasonable, cost-based fee.
Ask us to correct health and claims records	 You can ask us to correct your health and claims records if you think they are incorrect or incomplete. Ask us how to do this.
	 We may say "no" to your request, but we'll tell you why in writing within 60 days of your request.
Request confidential communications	 You can ask us to contact you in a specific way (for example, home or office phone) or to send mail to a different address.
	 We will consider all reasonable requests and must say "yes" if you tell us you would be in danger if we do not.

Your Rights (continued)		
Ask us to limit what we use or share	 You can ask us not to use or share certain health information for treatment, payment, or our operations. 	
	 We are not required to agree to your request, and we may say "no" if it would affect your care. 	
Get a list of those with whom we've shared information	 You can ask for a list (accounting) of the times we've shared your health information for six years prior to the date you ask, who we shared it with, and why. 	
	• We will include all the disclosures except for those about treatment, payment, and health care operations, and certain other disclosures (such as any you asked us to make). We'll provide one accounting a year for free but will charge a reasonable, cost-based fee if you ask for another one within 12 months.	
Get a copy of this privacy notice	 You can ask for a paper copy of this notice at any time, even if you have agreed to receive the notice electronically. We will provide you with a paper copy promptly. 	
Choose someone to act for you	 If you have given someone medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make choices about your health information. 	
	 We will make sure the person has this authority and can act for you before we take any action. 	
File a complaint if you feel your rights are violated	 You can complain if you feel we have violated your rights by contacting us using the information on page 1. 	
	 You can file a complaint with the U.S. Department of Health and Human Services Office for Civil Rights by sending a letter to 200 Independence Avenue, S.W., Washington, D.C. 20201, calling 1-877- 696-6775, or visiting <u>www.hhs.gov/ocr/privacy/hipaa/complaints/.</u> 	
	 We will not retaliate against you for filing a complaint.

If you have a clear preference for how we share your information in the situations described below, talk to us. Tell us what you want us to do, and we will follow your instructions.

In these cases, you have both the right and choice to tell us to:	 Share information with your family, close friends, or others involved in payment for your care Share information in a disaster relief situation Contact you for fundraising efforts
	If you are not able to tell us your preference, for example if you are unconscious, we may go ahead and share your information if we believe it is in your best interest. We may also share your information when needed to lessen a serious and imminent threat to health or safety.

How do we typically use or share your health information?

We typically use or share your health information in the following ways.

Run our organization	 We can use and disclose your information to run our organization and contact you when necessary. 	Example: We use health information about you to develop better services for you.
	 We are not allowed to use genetic information to decide whether we will give you coverage and the price of that coverage. 	
Pay for your health services	 We can use and disclose your health information as we pay for your health services. 	Example: We share information about you with your dental plan to coordinate payment for your dental work.
Administer your plan	 We may disclose your health information to government regulators for plan administration. 	Example: As a Medicare Advantage plan, we may disclose certain statistics or specific documents to government regulators as part of required reports or audits.

How else can we use or share your health information?

We are allowed or required to share your information in other ways – usually in ways that contribute to the public good, such as public health and research. Comply with the law	 We will share information about you if state or federal laws require it, including with the Department of Health and Human Services if it wants to see that we're complying with federal privacy law.
Respond to organ and tissue donation requests and work with a medical examiner or funeral director	 We can share health information about you with organ procurement organizations. We can share health information with a coroner, medical examiner, or funeral director when an individual dies.
Address workers' compensation, law enforcement, and other government requests	 We can use or share health information about you: For workers' compensation claims For law enforcement purposes or with a law enforcement official With health oversight agencies for activities authorized by law For special government functions such as military, national security, and presidential protective services
Respond to lawsuits and legal actions	 We can share health information about you in response to a court or administrative order, or in response to a subpoena.
Other uses or disclosures	 Certain federal and state laws may have additional privacy protections for health information such as HIV-related information, alcohol and substance abuse information, mental health information, and genetic information. We comply with those stricter laws where they apply.
	 We will only use and disclose psychotherapy notes with your written authorization unless otherwise required or permitted by law.
	 We do not use or disclose health information for marketing purposes.
	We do not sell health information.
